# **DRP-classification V8.01**

The new PCNE-DRP classification is almost ready. The last discussions about validity and validation will be held in Heldelberg, after the ESCP symposium, on the 11th of October.

Version 7 was not quite clear and complete. Therefore Version 8.01 was created during two meetings of experts in Bled and Brussels in spring 2017.

Changes are for instance following:

For clarity reasons, the problem domain now has the adjective '(also potential)', and the Causes domain has as adjective '(including possible causes for potential problems)'. When registering a problem, the person who scores must indicate if the problem is manifest or potential.

Unnecessary drug-treatment from section P1 moved to section P3

P1.3 (was P1.4) now changed to 'Untreated symptoms or indication'.

P2.1 added '(possibly)'.

P2: uses the term adverse drug event consistently now, and the domain name altered to 'Treatment safety'. (etc.)

# The Workshops in Fuengirola

#### WS1: Medication review after discharge

#### Facilitators: Jacqueline Hugtenburg-Rik Ensing

The most implemented service is currently the medication review, including reconciliation, at the transfer between care settings; in this case typically at hospital admission and discharge. What needs to be done in what order? What is the aim of this review? What is the role of other health care professionals besides the pharmacist, such as doctors and nurses?

#### WS2: Use of PCNE DRP-classification at care transition

#### Facilitators: Nejc Horvat-Foppe van Mil

In the transition of patients between care settings (homehospital-nursing home etc.), much information tends to gets lost. This often results in problems with the medications. Can the PCNE-DRP classification be used in these situations? Does it offer coding options for all types of problems that may occur, or are essential DRPs and their causes missing for these situations?

#### WS3: Guidelines and indicators for seamless care

#### Facilitators: Martina Teichert–Mitja Kos

It would be nice if all care transitions could be handled according to certain guidelines, with precise protocols. But even if such guidelines exist, that does not mean that they are properly managed. Indicators help to monitor the role and effect of guidelines. Which indicators are sensible, sensitive and usable?

#### WS4: Core outcome Set (COS) usable at discharge

#### Facilitators: Veerle Foulon-Charlotte Rossing

The discharge of a patient from hospital to home is ultimately meant to improve the quality of life of a patient, and decrease the financial burden on the health care system. What other outcomes of hospital discharge are important. Is it possible to define a Core Outcome Set, that will, help to monitor the impact of hospital discharge on the patient and his or her environment?

- The board of pharmaceutical sciences have embraced Pharmacy Practice Research in the new SIG group. This board had a conference in Stockholm in May 2017, and will have the next one in Canada in 4 years

- Amongst this year's award winners was our member Ariana Mestrovic, who was appointed FIP fellow.

If you want to present, or discuss your work, or seek cooperation partners, please inform the PCNE secretariat and we will insert your presentation in the schedule.


#### **General assembly**
