- In-depth discussion on the methodology that can / should be used to develop a COS
- Brainstorm on different themes (related to Pharmaceutical Care) for which a COS might be needed and could be developed
- Drafting a preliminary protocol for three COSs
- Consensus-exercise on which outcomes to select from a literature search for the selected COSs

## **Themes selected**

- 4
- COS for studies aiming to investigate the impact of pharmacists interventions in the management of anti-coagulant therapy (1)
- COS for studies investigating the impact of patient counseling on prescription drugs at the pharmacy counter (2)
- COS for studies investigating interventions aiming at continuity of medication management at hospital discharge (3)

# **Outcomes selected (1)**

- Time under therapeutic range
- Thrombo-embolic events
- Major bleeding
- Total bleeding
- ED visits (due to the use of Anti-Co)
- Hospitalization due to the use of Anti-Co
- All cause mortality

# **Outcomes selected (2a)**

- Drug handling problems
- Adherence
- Drug therapy problems
- (Patient) Security
- (Patient) Confidence
- Patient knowledge
- (Patient) Satisfaction

# **Outcomes selected (2b)**

- Achievement of (therapeutic) goal
- Therapeutic duplication
- Inappropriate prescribing
- Disease exacerbation
- Costs of drugs
- Extra visits to GPs
- Hospital admission
- Emergency visits

# **Outcomes selected (3)**

- Health related quality of life
- Medication-related hospital (re-)admission
- Potentially Inappropriate Medication
- Emergency department visits
- Medication profile appropriateness
- Adverse Drug Events
- Adherence
- GP post-discharge visits
